

# RULES

## CUMBRIA VETERAN LADIES' GOLF ASSOCIATION RULES – 2018

1. The Name of the organisation shall be Cumbria Veteran Ladies' Golf Association.
2. The minimum age limit shall be 50, as in other Northern Division Veteran' Associations.
3. Cumbria Veterans must be playing members of a Cumbria Club affiliated to CLCGA and England Golf. Cumbria Veterans may not be a member of any other County Veterans Association
4. The annual subscription shall be fixed by the committee. And will be due on 1st October and should be paid by 31st December.
5. Any member whose subscription has not been paid, shall not be eligible to enter any competition, nor to vote at a General meeting.
6. The Committee, who must be members of the Association, shall consist of President, Captain, Vice-Captain, Past Captain, Hon Secretary, Hon Competition Secretary and Hon Treasurer plus four committee members to be elected at the Annual General Meeting, each to serve for 3 years and only eligible for re nomination after 1 year.  
The Hon Secretary, Hon Competition Secretary & Hon Treasurer will serve for a period of 3 to 5 years whichever is preferable to the post holder to be nominated by the committee and voted in at the AGM.  
When voting for committee at the AGM members must make use of all their votes, nominations must be received by the Hon Secretary 28 days prior to the AGM  
The President shall be selected by the committee of the day and serve for a period of two years (1st one elected 2009)
7. The Captain shall preside at all Annual General, Special General and Committee Meetings, and in her absence the Chair shall be taken by the Vice- Captain.
8. In the event of an equal division taking place on any vote at any of the above Meetings, the Chairman shall have a casting vote in addition to the one she may already have given.
9. Fifteen members shall form a quorum for a General Meeting. Five members shall form a quorum for a committee meeting
10. The Committee may at any time invite any member of the Association to join the Committee, but any member joining shall retire at the end of the year.
11. The Hon. Secretary shall keep a record of all resolutions passed at any General or Committee Meetings, and such record upon being approved shall be signed by the Captain or Chairman for the time being.
12. The Hon. Treasurer shall keep a true account of all receipts and payments received and made on behalf of the association, and once every year shall prepare a statement showing the transactions. This account shall be scrutinized by a person approved by the Association, and copies shall be available at the AGM
13. Once every year, not later than 31st October, the Hon. Secretary will summon a General Meeting of the members of the Association.
14. Any member of the Association desiring to propose any resolution at any Annual Meeting must give written notice of the same to the Secretary 28 clear days before the Annual General Meeting.
15. All resolutions shall be voted on and the result shall be declared by the Chairman of the meeting, whose decision shall be final.
16. A Special General Meeting of the members of the Association may be summoned at any time by a resolution of the Committee or upon a written requisition signed by at least 50 members of the Association, and such requisition shall set out the nature of the business to be discussed or the resolution to be proposed.
17. In all the Association's Handicap Competitions, members must hold a current CONGU handicap.
18. The Committee shall have absolute power of settling all conditions under which any competition shall be played, and any dispute shall be referred to them for their decision, and such decision shall be final.
19. The Captain, Vice-Captain and Past Captain shall be responsible for the selection of the County Veteran Ladies' Team.
20. A Championship shall be held annually, the format to be decided by the Committee.
21. The Champion shall have the privilege of playing top for her team during her year as Champion.
22. Badges and team sweaters may be purchased from the Hon. Secretary or Captain. ' Colours will be awarded to a team Member after playing in 3 C.V.L.G.A. Matches. Badges will be awarded to Bronze Team Members after playing in 1 Bronze match.
23. Members shall notify the Hon. Secretary of any change of address
